Harm Reduction Explained Alliance for Positive Health

Harm Reduction Services are used to reduce the number of drug overdoses and prevent transmission of HIV, hepatitis C, and STIs. These services operate out of Plattsburgh and Glens Falls offices and serve Clinton, Franklin, Essex, Hamilton, Warren, and Washington counties.

Harm reduction strategies reduce:

- overdose incidences and deaths;
- acute infections related to unsterile drug injection;
- chronic diseases such as HIV/HCV; and
- unintended contact with syringes

Free harm reduction supplies

For sterile and safe injection/use.

- Free Narcan
- Free testing
- Free fentanyl test strips
- Free hygiene supplies
